The following document has been prepared in accordance with the provisions of articles 13-14 of EU Regulation 2016/679.

Fonderie Mario Mazzucconi S.p.A., in its capacity as data controller, collects and processes personal data provided by data subjects in the course of its activities. To ensure the protection and the exercise of the rights provided for by the law on the protection of personal data, data subjects are informed that:

Purposes of the processing

The data provided by the data subjects will be processed for the purpose of fulfilling the provisions of the contract entered into signed which include one or more of the following purposes:

- Conducting business operations and pre-contractual and contractual relations

In addition to the personnel assigned to administer your contract, the data may be processed by the following parties:

- 1) Postal and logistics companies.
- 2) ICT service providers.

- 4) Credit institutions
- 5) Consulting firms

Within the framework of the contract activities and pursuant to article 49 paragraph B of EU regulation 2016/679, Fonderie Mario Mazzucconi S.p.A. may transfer the personal data of data subjects to non-EU countries for purposes related to the performance of the contract.

Where we store your data

Fonderie Mario Mazzucconi S.p.A. stores the personal data of data subjects within EU member countries. The personal data of data subjects will be stored in paper form or electronically.

How data subjects can exercise their rights

Pursuant to the provisions of article 13, paragraph 2 of EU regulation 2016/679, data subjects are informed of the modalities for the exercise of their rights.

Data subjects are informed that, pursuant to article 12, paragraph 3, of EU regulation 2016/679, Fonderie Mario Mazzucconi S.p.A. has

- a) one month from the receipt of a request by the data subject for exercising of the rights listed below to respond in this regard.
- b) that period may be extended by two further months, where justified by the number of the requests.

Data storage period

Data subjects are informed that the personal data provided shall be stored for the entire duration of the contract to which this statement is attached. Any data that may arise from subsequent contractual relations (e.g. tax documentation) will be stored in accordance with the provisions of law.

Rights of the data subject

Pursuant to articles 15-22 of EU regulation 2016/679, Fonderie Mario Mazzucconi S.p.A. hereby undertakes to ensure the full exercise of the rights of the data subject, except where this prejudices a legitimate right or the rights of other data subjects. Data subjects are informed that, pursuant to article 13, paragraph 2 (d) of EU regulation 2016/679, in the event of a serious non-compliance or a failure to uphold one of the rights listed in this statement by Fonderie Mario Mazzucconi S.p.A., they may lodge a formal complaint with the national data protection authority.
